RE: Discontinuation of All Treatment Products

Dear Guardian Protection Products East Texas/Oklahoma,

GUARDIAN

As previously communicated to you in March and April, there is a national push to restrict the use of fluorine in cleaning products. California's law went into effect April 1st, 2022 and prohibits the sale of any formula containing fluorine to the public beyond September 27, 2022.

To comply with this new regulation, Guardian will cease manufacture and sale of these products for California, as of **August 5, 2022**. In addition, Guardian will require each distributor to acknowledge their compliance with this directive and provide notice to each one of their customers. You are required to send us a response to this email/letter acknowledging your understanding and documentation of notices to your customers.

We realize that this is an imposition and restriction on product sales, but Guardian must comply with this regulation, and we must ensure that you are complying with it as well. You should plan inventories with your customers; you will be responsible for all costs associated with unsold product.

The alternative formula that has been presented to us by our chemists, exhibits significantly reduced stain repellant properties. Taking this into account and the fact that there is pending legislation in Washington State, Vermont, Maine, and several other states to incorporate these restrictions, we will not be producing alternative products in the future across the business in any territory. We will permit purchase of these products through **September 30, 2022**, for sale in any other state in the United States other than California, Washington, Vermont, and Maine, but after that date we will no longer be offering above referenced SKU's for sale in any state. We are disappointed, but due to the small volumes produced for these products, we do not foresee this being too much of an imposition or disruption to your current business. We appreciate your cooperation in assisting us with these new statutes. Should there be any changes, we will communicate them to you.
