To Whom It May Concern,

The following documentation represents a Chemicals of Concern Substance/Chemical Name and CAS# Search on the most currently available list provided by the California Department of Toxic Substance Control (DTSC) as of November 23, 2022 and as pulled from the CalSAFER website. Searches performed were done using both the chemical name of the replacement chemical and the associated CAS# in determination of whether the substances/ chemicals are present on the "Chemicals of Concern" list. Specific searches performed were for:

- Polydimethylsiloxane (Dimethicone), CAS# 9006-65-9 which replaces the former PFAS component in the 303® Fabric Guard.
- Amodimethicone, CAS# 71750-80-6 which replaces the former PFAS component in the Trinova® Stain Guard.
