



ZIP-STRIP® INDUSTRIAL PAINT & FINISH REMOVER

REMOVES: Enamel, latex and acrylic paint, varnish, lacquer, shellac, urethane, polyurethane, epoxy finishes and aids in stain removal. Will not raise the grain of wood, harm metal or genuine leather. Do not use on synthetic fabrics, rayon, nylon, linoleum, asphalt, foam products or rubber tile. May soften fiberglass or plastic.

DIRECTIONS: Wear safety glasses and thick heavy duty rubber gloves. **USE CAUTION WHEN OPENING.** Apply liberally, brushing in one direction only. Leave on from 10-20 minutes, depending on the number of coats of old finish to be removed. After finish bubbles loose from surface, remove with scraper, steel wool or **wash off** with a scrub brush or coarse rag and cool water before old finish dries. Do not let softened finish dry. Scraping with a wide-blade putty knife is the preferred method for wood surfaces as water will raise the wood grain. Some finishes such as varnish, epoxy and latex will not wrinkle or bubble. Pretest for removal time before use. Use old brush - discard after use. Do not use in direct sunlight or on hot surfaces. Do not rush the remover, let Zip-Strip do the work. **ON FLOORS:** Clean all remover from cracks and joints. Allow to dry thoroughly (at least 24 hours) before refinishing. **FINAL CLEAN-UP:** Use fine steel wool dipped in Zip-Strip or paint thinner. Wipe surface thoroughly with clean cloth. Allow to dry overnight before finishing. **STAINS:** To acquire a lighter tone, scrub surface with steel wool and a combination of 8 parts Zip-Strip and 1 part bleach.

CONTAINS: Methylene Chloride (CAS# 75-09-2), Methanol (CAS# 67-56-1), Mineral Spirits (CAS# 8052-41-3) and Nonylphenol Polyethylene Glycol Ether (CAS# 9016-45-9). Cannot be made non-poisonous. VOC less than 50%. This product is non-photochemically reactive.
